**Subject: Guidelines for Implementation of Migration to IS/IEC 62368-1:2023 pursuant to MeitY's Notification dated 29 October 2025 under the Electronics and Information Technology Goods (Requirement of Compulsory Registration) Order, 2021.**

1. Ministry of Electronics and Information Technology (MeitY) has vide their Notification S.O. 4997(E) dated 29 October 2025, amended the Electronics and Information Technology Goods (Requirement of Compulsory Registration) Order, 2021 notifying IS/IEC 62368-1:2023, Audio/Video, Information and Communication Technology Equipment – Part 1: Safety Requirements which supersedes the following Indian Standards covered under CRO:

- IS 13252 (Part 1):2010
- IS 616:2017

2. As per the said notification, the last date of concurrent running of IS 13252 (Part 1):2010 and IS 616:2017 with IS/IEC 62368-1:2023 is until **01 November 2028**, for the following products:

After **01 November 2028**, IS 13252 (Part 1):2010 and IS 616:2017 shall stand withdrawn for the above product categories.

3. For the purpose of these guidelines, all licensees and applicants shall refer to the series guidelines as per IS/IEC 62368-1:2023 to be issued by MeitY.

4. Implementation guidelines shall be as follows:

**A. Existing Licensees:**

- 1) All existing licensees shall implement the IS/IEC 62368-1:2023 by the last date of concurrent running i.e. 01 November 2028. Beyond the last date of concurrent running, no licence shall be operative where compliance to IS/IEC 62368-1:2023 has not been ensured by the licensee.
- 2) Existing licensees shall ensure conformance to IS/IEC 62368-1:2023 through submission of complete test Report(s) issued by BIS recognized laboratory for all lead model(s) as per IS/IEC 62368-1:2023, in their scope of licence which had been previously tested as per IS 13252(Part1):2010 or IS 616:2017 by submission of the test report through Standard Revision/Amendment/ Essential Requirement provision available at their login ids.
- 3) Further, the licensees shall provide an undertaking stating that requirements of IS/IEC 62368-1:2023 have been implemented in other existing series model(s) which are in the scope of the licence. In this regard, reference shall be made to the revised series guidelines to be issued by MeitY
- 4) If the licensee fails to complete all actions by the last date of implementation of IS/IEC 62368-1:2023, cancellation of the licence/ deletion of model from the scope of the licence may be initiated.
- 5) On successful implementation of the IS/IEC 62368-1:2023, BIS shall issue a letter indicating all the model(s) for which the compliance has been successfully established.

- 6) If compliance with IS/IEC 62368-1:2023 in any Registered model impacts the compliance to the following:
- IS 18112:2025 applicable to the product category **Plasma/LCD/LED Televisions and Television Sets** listed at S. No. 3 and 32 of the above table.
  - IS 16333 (Part 3): 2022 for product category **Mobile Phones** listed at S. No. 16 of the above table and,
  - Essential Requirement(s) for Security of IP-based CCTV Cameras for the product category **CCTV Cameras** listed at S. No. 24 of the above table,

then compliance to the above ISs/ Essential Requirement(s) is also to be ensured by the licensees by submission of complete Test Reports along with the test reports of IS/IEC 62368-1:2023.

- 7) If compliance with IS/IEC 62368-1:2023 in any Registered model does not have any impact on compliance with the following:
- IS 18112:2025 for the product category **Plasma/LCD/LED Televisions and Television Sets**;
  - IS 16333 (Part 3):2022 for the product category **Mobile Phones**; and
  - Essential Requirement(s) for Security of IP-based CCTV Cameras for the product category **CCTV Cameras**,

then licensee shall submit a duly signed declaration in this regard along with the test reports of IS/IEC 62368-1:2023.

#### **B. For New Applicants:**

- 1) Applications where samples have already been submitted to the laboratory and/or test reports have been issued under IS 13252 (Part 1):2010 or IS 616:2017 may be processed under the old standards.
- 2) Applications which are recorded henceforth may be processed as per IS 13252(Part1):2010 / IS 616:2017 or as per IS/IEC 62368-1:2023. Processing of Applications as per old standard shall be permitted only up to the last date of concurrent running of IS/IEC 62368-1:2023. For such cases, the applicant shall give a declaration that they will implement IS/IEC 62368-1:2023 by the last date of concurrent running.
- 3) Beyond the last date of concurrent running of IS/IEC 62368-1:2023, no licence shall be granted as per IS 13252(Part1):2010 or IS 616:2017.

#### **C. For Change in Scope of Licence**

- 1) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
  - 2) However, processing of requests for change in scope of licence as per IS 13252(Part1):2010/ IS 616:2017 shall be permitted only upto the date of switchover to IS/IEC 62368-1:2023 by the licensee or up to the last date of concurrent running of IS/IEC 62368-1:2023, whichever is earlier.
5. The above guidelines shall come into force with immediate effect.
